Participants gain real-world skills in baking, food safety and customer service while earning minimum wage and ServSafe certification – building a pathway to long-term employment and independence. Up to 40 individuals will benefit each year, gaining confidence, job readiness and meaningful community connections.

By 2029, St. Coletta's will fully phase out subminimum wage activities – advancing a more inclusive workforce for all.

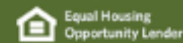
